Michael J. Fogarty, Former Lighting Co. Executive, Is Buried

High Mass of requiem for Michael J. Fogarty, seventy-nine, retired executive of the Erie Lighting company, whose death occurred Monday in his home, 312 Cherokee dr., was celebrated Thursday morning in St. Peter's cathedral. Interment took place in Trinity cemetery.

Born in Louisville, Ky., Mr. Fogarty came to Erie when a small child and for more than 70 years made this city his home. He was one of the pioneers in the electrical business in this section and was connected with the Erie Lighting
